A big plus is that the Lodge will allow us to have table sales. Imagine, train sales for the first time in six months! We will be using the round tables that the Lodge normally has setup so we do not have setup and tear down hall issues. We have used rounds in the past for table sales and the auction so everything should be fine.

By the way, a five-foot round table has more area than a regular six-foot-long rectangle table. I will let my High School calculations speak for themselves unless a math wizard wants to prove me wrong.

We will have hand sanitizer available at the meet and if you do not feel well, please stay home. For those of you who still do not want to step out into the public just yet we will try something **new for the September Meeting. We will broadcast the meeting live on YouTube**.

That's right. If you cannot join us in person, join us from the comfort of your home as we broadcast our meet live. It will be available following the meet for you to view as well.

Because of current CDC guidelines along with those of the Elks Lodge we cannot bring in our coffee and donuts so plan to bring your own brew that morning.

The September Meet will be our first in person get together, but we have a few other events planned as well. Depending on the turnout and how local conditions in Arizona fair during this part of the reopening, we will hold an October Meet. That location has yet to be determined but we hope by then to be in our new location.

The City of Scottsdale has canceled Rail Fair this year. While covid was a serious component of the decision, the huge uncertainty of making a profit was also a major concern. Rail

Fair is a major fund-raising event and the expense for all the tent, table and other associated rental expenses the public needs to show up and ride the different attractions. With all the current social distancing guidelines the numbers just didn't add up.

The Fall Auction is scheduled to take place on November 7th at the Paradise Valley United Methodist Church. We will have catalogs for sale at the September meet. For those that you who cannot attend the Meet and want a catalog, contact us and we will mail it to you. The cost is \$5 and if you bring that catalog to the auction, that is your free admission ticket. The catalog will be available online at the Division website mid to late October.

The November Train Show at the Shrine Auditorium has been cancelled for this year. We just do not have any confidence that the fifty-person indoor limit will change enough for us to host the show. The safety of our front-end volunteers along with the safety of all our members and table holders was a crucial part of our decision. Add the huge task of trying to account and police the event with our limited crew of volunteers just made the event too much of a gamble for us this year. We are still investigating hosting an outdoor Swap Meet and will keep everyone posted as we work to find a suitable location.

The last event on the 2020 calendar is the Holiday Christmas Party. We worked closely with the Hilton DoubleTree and were satisfied that they were following all the current guidelines for us to host the party safely. We also heard from the Holiday Christmas Party Committee who voiced their own concerns.

The Board decided that this just was not the time or year to host a party and have cancelled the Holiday Christmas Party for 2020.

None of the decisions has come easily and some may change as the situations warrant. Planning in August how things will be several months from now is just as hard as planning in February how things would look in May. We do our best and remain flexible.

SURVEY RESULTS

The Division Board appreciated the high percentage of members who participated in last **month's** survey. Not only did it indicate how passionate and concerned some of our members view the current Covid season, but how widely split we are as a group and the desire to get back together.

The survey was just that, a survey. It was not a vote where the majority rules, but rather a general indication of how our members felt in attending various club functions. Every answer was important. We could have been very selective on who we sent the survey out to, excluding members who live outside of our general commute area, but we didn't. We also did not make it clear that you could leave a question blank if you didn't normally attend that particular event. That resulted in some skewed results.

Take for example the question on would you attend the Division September Meet? We had a total of 72 responses of which 46 said No and 36 said yes.

By a simple head count it would seem that we should not hold a Meet as the majority did not want one, correct? Well, let's look at the numbers and discuss how the Board looked at the responses.

Just a quick glance tells us that we have not had 72 total members at a meet since we left the Scottsdale Jaycee Hall over a decade ago.

There is no way to cull the answers to get the data we needed since we used election software and your answers are anonymous. But we were able to see what email addresses successfully submitted a "ballot". This is part of the fraud prevention built into the software as some married couples share the same common email address. This way both Jack and Jill can vote, have unique voter id numbers, and the fraud analysis indicate two votes were received from the same email address.

Using the fraud analysis, we were able to see what emails successfully submitted "a ballot", then working backward see where those emails lived. 71 responses came from Arizona, 13 from New Mexico and 5 from out of state.

It quickly became evident that in some members minds that they were simply responding to the question "would you attend" rather than a better worded question would have been "do you normally attend the September Meet and do you plan to attend the September meet if held next month?"

This became more defined when we looked at the results to the New Mexico Rio Grande Chapter September Meet question where we had 39 responses where there should have been only 13.

Using the figures of past participation helped us decide each events outcome for the remainder of the year. Current government and health regulations may also cancel planned events as the situation changes.

TCA Desert Division BOD Teleconference August 18, 2020

A Desert Division Board of Directors Teleconference was held on August 18, 2020, and was called to order at 6:15 PM MST

In Attendance; Chris Allen, Mike Dietrich, Mark Thompson, Angelo Lautazi, Steve Bienstock, Paul Wassermann

Approval of Previous Meetings Minutes – Previous minutes were approved as distributed.

Secretary's Report - Angelo reported that current Division active (dues paying) membership is 185.

<u>Treasurers Report</u> - Treasurer Mark Thompson reported the following balances: Checking \$12,298.04 Savings \$190.01, Six month CD \$20,000.23 Mark also noted for the record that he purchased new checks from the new bank and had other associated expenses with moving the accounts and getting setup with the new Credit Union.

Old Business:

<u>Division Incorporation</u> – Paperwork has been filed with the IRS for the Division to be approved as a 501(c)(3) charity. According to the IRS website under the current Covid situation requests can take up to sixty (60) days before we will hear anything on our request. Chris said he would keep the board advised if anything was heard before the next scheduled board meeting.

<u>Division Bylaw changes</u> – The Bylaws were reviewed by the National TCA Rules and Regulations Committee and one additional change was requested. After review and discussion the change was approved. **Motion by Paul Wassermann:** "I move that the Board accept the change to the Division Bylaws in Article XI Section 2 as presented to the Division." Motion was seconded and passed unanimously. Discussion followed; it is now up to the National TCA Board of Directors to approve all the changes. Once they approve the changes the Division membership will vote to accept these new Bylaws still scheduled for the January Annual Business Meeting.

New Business:

<u>Member Survey</u> — The Board discussed the recently completed survey. The instructions for filling out the survey were apparently not clear enough. Many members filled out the survey for events they would never attend. An example was that thirteen members from the Rio Grande Chapter filled in the survey, yet we recorded thirty-nine responses for the two questions that only dealt with meets and meetings in New Mexico. Discussion continued how much was valid and Chris brought up the results of the second survey sent to only Rio Grande Chapter members and the current downward trends in reported cases along with the continued businesses open in Arizona. The Board took the following actions based on available data and survey responses.

<u>September General Meet</u> – Will be held, based on how many attend we will decide on holding an October Meet. Chris announced that Aldersgate Methodist currently will not rent the facility to the public and turned the discussion over to Mark. Mark stated that he had secured the Phoenix Elks Lodge for the morning at the same cost of the church rental. Masks will be required inside the Lodge during the meeting, but we will be able to have sales tables.

Rail Fair October 4-5 – We will participate if the event is held. We still no official word from the City of Scottsdale.

<u>November Train Auction</u> – We will hold the event as planned. Currently a limit of fifty-person attendance is in effect. Although this may change this is the normal attendance for an auction. The lunch is being determined since buffet style that we have used in the past is no longer acceptable. Chris will finalize the contract and insurance.

<u>Desert Division Train Show 2020</u> – With the current fifty-person limit in place the Board has cancelled the event. Chris will notify the Shrine and reschedule for next year. The option for an outdoor Swap Meet was discussed. The logistics of restroom facilities, tables, and dates were considered. Chris will explore possible locations and report back to the Board.

<u>Christmas Party 2020</u> – The Christmas Holiday Committee has expressed their desire to cancel the party for this year. The BOD discussed their concerns and agreed. The Holiday Party will be cancelled this year and we will work with Fred Hunter to get the Lenox ornaments delivered to those members who ordered them.

<u>Adjournment</u>: The next meeting will be held by teleconference at a date to be determined. Meeting was adjourned at 7:20 PM

Elevated Train Project

My 2020 train project all started several years ago when I had the opportunity to purchase a trunk filled with an American Flyer Wide Gauge Steam Engine Freight Set. It included a #4680 Steam Engine and #4671 Tender, a #4021 Type G caboose, #4022 VC Log Car, #4018 Auto Carrier, #4017 VC Gondola, and a Flat Car and Boxcar both being homemade either from scratch or a kit. The Engine and tender were in excellent condition, but the other cars, which had been stored in the trunk in a shed with a leaky roof, needed work. After cleaning, repair, and painting, I now needed a place to display them.




Looking around the train room at the existing shelves, I decided that maybe a wider shelf on the top of the corner one would work. Then an idea that had been simmering for some time, presented itself – how about an elevated rail line!!



Off to a slow start, I added and amended the corner shelves putting wider and curved boards on top. I then extended the shelf along one wall to run above the already existing display shelves that hold my Lionel Standard Gauge Cars.

Then came the where and how to suspend the track across the room. The ceiling beams worked good for the suspension rods and ¾" plywood. In the middle I designed a 46" Bridge cut out of plywood and painted it red. It lifts out for cleaning purposes. The big challenge here is the ceiling fan I had to keep the bridge below the fan and the suspension rods had to be spaced to allow the fan blades to pass by.



The Bridge design is based on a King Post Truss and Burr Arch design that was used in the building of Covered Bridges in Pennsylvania. These Bridges were built with Heavy Timbers, I used the lighter plywood version. As you can see this required gluing, clamping and small nails to construct the bridge. I then took it outside for priming and painting red.

The next thing I needed was Gargraves Standard Gauge Track, so a phone call to Peter Atonna solved that problem and then thanks to Peter I had 10 - 37" sections of track in a week. I used the Gargraves track in conjunction with the like new curved track that came with the Flyer


